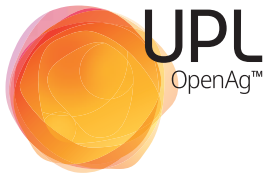

### WEED MANAGEMENT SUGGESTIONS:

For optimal weed control, the following weed management programs are suggested:

- Apply a pre-emergent residual herbicide prior to, or at planting.
- Apply paraquat + Moccasin MTZ if burndown at plant is necessary.
- Apply first postemergent application of Interline at 32-43 fl oz/acre to glufosinate tolerant soybeans when weeds are 3-4 inches maximum height.
- Interline herbicide may be tank mixed with other herbicides for broad-spectrum weed control, including Moccasin brands, glyphosate or Enlist One.
- Apply a second timely application of Interline if needed.
- Optimum water volume is 15 gallons per acre. Use 43 fl oz of Interline and 20 gallons of water if weed population is dense. Make a sequential Interline application 5 - 10 days later, if necessary.
